(The Department's name was changed to the Missouri Department of Commerce and Insurance on Aug. 28, 2019.) The Missouri Senate confirmed her on April 13, 2017.

In this role, Director Lindley-Myers leads the Department that protects consumers and ensures a strong and stable insurance market by regulating professionals and businesses that affect Missourians' lives daily.

Director Lindley-Myers has held several senior positions in the legislative, judicial, and executive branches of government, as well as leadership roles in the regulatory and insurance industries. At the Tennessee Department of Commerce and Insurance, she oversaw the Insurance, Securities, Tennessee Law Enforcement Academy, and TennCare Oversight divisions, as well as the human resources and legislative functions. She also served in Kansas City as the Director of the Consumer Protection and Anti-Fraud Division of the NAIC, as Chief Compliance Officer of Examinations for the Kentucky Department of Insurance (DOI), and as the Property and Casualty Section Chief for the Missouri DOI.

2015 Robert Dineen Award for outstanding service and contribution
to the state regulation of insurance.

Director Lindley-Myers currently serves as the 2024 Past-President of the NAIC and in additional leadership roles with the NAIC. She was also elected to the Executive Committee of the International Association of Insurance Supervisors (IAIS) in April 2024.
