- Workgroup 3: Evaluate tools and resources for monitoring industry's use of data and AI/ML.
- Lead by: Co-Vice Chair Adrienne Harris, New York
- **Process**: Gather data and evaluate information from sources, including vendors, academics, industry, international supervisory authorities, on governance models/frameworks and software tools/resources, which could assist regulators in overseeing and monitoring industry's use of data and AI/ML and eliminate unintended bias in such use. Coordinate with other NAIC committees engaged in similar efforts.
- **Deliverable**: Contribute summaries of suggested regulatory strategies to the working group for referral to the H Committee.
- Timeline: On-Going

- Seeking to learn ways the industry works to detect and mitigate for bias in AI/ML activity related to <u>Claims</u>, <u>Underwriting</u>, and <u>Rating</u> use areas.
- Key Research Questions we want your input!

- 2. What governance frameworks are industry using or are available for managing its AI/ML activity?

# Agenda Item #2D Regulatory Framework/Governance

The members of the Big Data and Artificial Intelligence (H) Working Group Workstream #4 invite the insurance industry and consumer representative stakeholders to offer input and comments on published governance frameworks related to Artificial Intelligence such as but not limited to, the NIST Draft Risk Management Framework, the ISACA Governance Framework for Artificial Intelligence, the EIOPA Artificial Intelligence Governance Principles or other international published guidance such as Singapore's Al Governance Framework.

The results of the NAIC Al/ML Private Personal Auto survey indicated relatively few companies using existing standards or guidance developed by third-parties — or even a hybrid internally developed and third-party component framework. The members of the workstream are interested to better understand industry's reasons for not adopting a standard or publicly available governance framework or if the survey results should not be interpreted to that conclusion. The workstream members seek input regarding components of these various frameworks that might be commonly acknowledged as best practices, foundational components of a sound governance model.
