Evan M. Eastman



Evan M. Eastman is the Independent Life & Accident Insurance Associate Professor in the Dr. William T. Hold/The National Alliance Program in Risk Management and Insurance in the College of Business at Florida State University. He holds a B.S. in Economics from the Pennsylvania State University and a Ph.D. in Risk Management and Insurance from the University of Georgia. His current research focuses on financial accounting, taxation, enterprise risk management, and regulation. His work has been published in *The Accounting Review*, the *Journal of Risk and Insurance*, the *North American Actuarial Journal*, and the *Risk Management and Insurance Review*.

Evan's work has been presented at conferences including the FARS Midyear Meeting, the AAA Auditing Midyear Meeting, the ATA Midyear Meeting American Risk and Insurance Association, and the Financial Management Association, among others. His research has won awards from academic organizations as well as been cited by regulatory bodies. He has served as a reviewer for the *Journal of Risk and Insurance*, the *North American Actuarial Journal*, the *Journal of Insurance Issues*, the *Journal of Insurance Regulation*, and the *Risk Management and Insurance Review*. In addition to research, Evan's teaching includes principles of risk management and insurance, life and health insurance, and insurer operations.



Janis Potter

Janis Potter, Certified Public Accountant, is the Executive Director of the Illinois Life & Health Insurance Guaranty Association. She provides leadership in supporting insolvency, organizational and financial plans with the Board of Directors and staff and carries out plans and policies authorized by the Board. She is the primary contact to the Board of Directors and the Executive, Nominating, Audit & Finance, and Legal Committees, including the responsibility for oversight of staffing of all committees.
