Hi Petra,

Damion Hughes, Director of Market Regulation in Colorado, forwarded information to me regarding the data requests for title examination. I have little of substance to contribute, but would reorganize some of the data fields in the **CLAIMS STANDARDIZED DATA REQUEST**, as noted in my response to Damion, reprinted below.

Please see below as my only comments or contribution.

I have no comment on the **POLICY IN FORCE STANDARDIZED DATA REQUEST**. I appreciate the additions to the Data Request and think it is a good result. Particularly appreciate the addition of data regarding a reissue policy. In the exam process, determining that status has caused me some difficulty in the past.

As for the **Claims Data Request**, the order of the request for the Data -after the Owner Name -does not really follow a logical pattern in the way I examine claims. I suggest keeping all of the information, but reordering the data request (after owners last name) as follows:

- First notice of loss [MM/DD/YYYY]
- Date company or its producer acknowledged the claim [MM/DD/YYYY]
- Date of written notice to insured/claimant regarding incomplete investigation [MM/DD/YYYY]
- Date claim opened [MM/DD/YYYY]
- Date reserves established for claim, if applicable [MM/DD/YYYY]
- Aggregate amount of reserves established for claim
- Aggregate amount of claim expenses (litigation, research fees, etc.)
- Is claim currently in litigation (Y/N)
- Claim referred to outside counsel (Y/N)
- Date referred for legal counsel [MM/DD/YYYY]
- Claim status P = Paid, D = Denied, N = Pending, H = Partial Payment, C = Closed Without Payment, R = Rescinded
- Claim paid date [MM/DD/YYYY]
- Claim payment amount
- Date claim was denied [MM/DD/YYYY]
- Date claim closed [MM/DD/YYYY]
- End of record marker. Please place an asterisk in this field to indicate the end of the record.

I am happy to discuss or post this info if you can help me get there.

Hope the information is helpful to you.
