## **Release of the 2020 *Market Regulation Handbook***

The 2020 edition of the *Market Regulation Handbook* was released July 2020.

The 2020 edition of the *Market Regulation Handbook* incorporates all revisions adopted by the NAIC in 2019.

## **New in 2020**

Due to the work-from-home and social distancing requirements caused by the COVID-19 pandemic, the NAIC has suspended shipment of publications. However, demand remains high for accessible content in a work-from-home environment. As a result, there is a business need to make access to online content available to customers working remotely.

In order to meet these needs, the NAIC is pleased to announce the 2020 *Market Regulation Handbook* will be offered as a digital-only publication via an online subscription service (OSS). This new subscription service provides access to the published version of the handbook, and Market Regulation Handbook Reference Documents will be available in Account Manager. Modifications to the handbook will be uploaded to the OSS platform as they become available following each interim and national meeting of the Market Regulation and Consumer Affairs (D) Committee. Subscriptions are specific to an individual user and access to the platform requires a redemption code, which will be provided via email following verification of the purchase.
