Alabama	Scroll down to and select: Appropriate statement type under Annual Statement and Related Filings (NAIC Check-List)
Alaska	Select: Appropriate statement type. Select Annual Filings Checklist.
Arizona	On left side, open Financial Reporting for Domestic or Foreign/Alien Entities. Scroll down and select statement type. Select: E-NAIC.* -* = Statement type (Health, LD, PC, Title, Fraternal)
Arkansas	Select: Financial Statement and Other Filings Checklist-(PDF) under appropriate statement type under Financial Checklist.
California	Scroll down to Forms and select: Appropriate business type. Scroll down and select: [statement type] Checklist shown above table.
Colorado	Select: Appropriate business type. Select: Required Filings from list in box. (Note: The General Instructions and Filing Checklist are separate documents.)
Connecticut	Scroll down to Annual Financial Filing Requirements and select appropriate business type. Automatically downloads the PDF.
Delaware	Select Annual Filing Checklists under Checklists. Scroll down and select: * Checklist. * = Appropriate business type.
District of Columbia	Select: Appropriate business type. Automatically downloads doc.

Indiana	Under Company/Entity Financial Compliance, scroll down to Filings>Annual/Quarterly Statements. Select: appropriate statement type. Click for Instructions and Checklist separately.
Iowa	Scroll to appropriate statement type under Premium Tax Filings and select Annual Statement Filing Instructions Checklist and Due Dates.
Kansas	Scroll to 2024 Checklists. (Correct year is attached.) Select: Appropriate statement type. Automatically downloads as a doc.
