

The State Insurance Charts consist of more than 100 issue-specific charts, combining states' statutes and regulations on various insurance topics in a concise and clear format. Typically, charts are updated every two years unless “upon request” is indicated. A request for a chart to be updated should be submitted to the Legal Division at LegalOperations@naic.org.

These charts do not constitute a formal legal opinion by the NAIC staff on the provisions of state law and should not be relied upon as such. Every effort has been made to provide correct and accurate summaries to assist the reader in targeting useful information. For further details, the statutes and regulations cited should be consulted. The NAIC attempts to provide current information; however, readers should consult state law for additional adoptions.
