SUBJECT: State Legislator Program at NAIC 2024 Fall National Meeting (Nov. 16-17)

Each year, during a designated national meeting, the National Association of Insurance Commissioners (NAIC) organizes an in-person program for state legislators and state government officials across the country to connect with one another, learn more about the NAIC's role in supporting state-based insurance regulation, and discuss regulatory and policy developments at the NAIC and in the states.

We are excited to share that the NAIC's 16<sup>th</sup> Annual State Legislator Program will be held during the NAIC 2024 Fall National Meeting in Denver, Colorado, at the Gaylord Rockies Hotel & Convention Center. **The Program will begin on Saturday, November 16 and conclude on Sunday, November 17. As such, we recommend arriving to Denver on Friday, November 15 and, depending on your return destination and availability, departing either on Sunday evening, November 17 following the conclusion of the Program, or departing on Monday, December 4.**

Among other events, the State Legislator Program will consist of a welcome reception, a dialogue between commissioners and legislators, and a series of breakout sessions. The breakout sessions, led by regulators, including commissioners, and NAIC staff, provide legislators with the opportunity to delve deeper into a range of timely insurance issues and discuss various legislative approaches with their peers. **Please see page 3 for the tentative Program schedule.**

For participating legislators, the NAIC will cover registration, transportation, lodging, and meal expenses.

**If you are interested in participating in the Program, please confirm with your commissioner/insurance department by October 16.** The NAIC will then send registration details directly to you. Because airfare and lodging will be booked directly through the NAIC and billed to the NAIC's account, please refrain from making travel or hotel plans until you receive further guidance from the NAIC.
