RE: The Federal Insurance Office Act of 2009, Manager's Amendment

Dear Chairman Frank, Ranking Member Bachus, Chairman Kanjorski, and Ranking Member Biggert:

We write to thank you for working with the National Association of Insurance Commissioners (NAIC) on the significant improvements to the Federal Insurance Office Act of 2009 proposed by the latest amendment to the legislation. These changes, identified in an October 23rd letter from our CEO to the Committee, strike an appropriate balance among the needs of consumers, state regulators, and federal negotiators by preserving important state prudential and market regulation while allowing for agreements with equivalent regulatory systems.

State regulation of insurance has worked extremely well for consumers during the financial crisis, protecting policyholders and prohibiting insurers from engaging in the activities that have crippled the financial sector. As such, we will continue to oppose a federal functional regulator for insurance or misguided attempts to further empower the FIO, but as currently drafted, the FIO is an appropriately narrow and targeted improvement to our system of supervision. Therefore, the National Association of Insurance Commissioners (NAIC) supports the legislation as amended.




