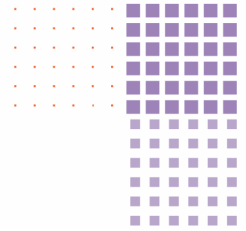

Meeting Summary Report

The Health Insurance and Managed Care (B) Committee met Aug. 13, 2025. During this meeting, the Committee:

1. Adopted its Spring National Meeting minutes.
2. Adopted the report of the Consumer Information (B) Working Group, including its June 26 minutes. During this meeting, the Working Group took the following action:
 - A. Adopted its April 14 minutes. During this meeting, the Working Group took the following action:
 - i. Discussed a consumer advisory on health insurance.
 - B. Discussed a consumer guide on selecting a health plan and avoiding improper marketing practices.
3. Adopted the report of the Health Innovations (B) Working Group, which met Aug. 12. During this meeting, the Working Group took the following action:
 - A. Adopted its June 20 minutes. During this meeting, the Working Group took the following action:
 - i. Adopted its April 24 minutes. During this meeting, the Working Group took the following action:
 - a. Heard presentations on three sections of the Affordable Care Act (ACA) that provide flexibility to the states.
 - ii. Heard a presentation from the Center for Consumer Information and Insurance Oversight (CCIIO) on health care choice compacts under Section 1333 of the ACA.
 - iii. Heard presentations on state experiences with flexibility under Sections 1331 and 1332 of the ACA.
 - B. Discussed a request from the federal Centers for Medicare & Medicaid Services (CMS) for consultation on health care choice compacts.
 - C. Heard stakeholder comments on an outline for a white paper on state flexibility under the ACA.
4. Adopted the report of the Health Actuarial (B) Task Force.
5. Adopted the report of the Regulatory Framework (B) Task Force.
6. Adopted the report of the Senior Issues (B) Task Force.



7. Received an update on the Long-Term Care Insurance Multistate Rate Review Framework (LTCI MSA Framework). The Health Actuarial (B) Task Force adopted revisions to the LTCI MSA Framework on July 14. After discussion, the Committee adopted the LTCI MSA Framework, which the Executive (EX) Committee and Plenary will consider for adoption at the Fall National Meeting.
8. Heard a discussion of 2025 state legislative activity of interest to the Committee.
9. Heard the presentation “Supporting Medicaid Members and Patients: Eligibility Redeterminations and Learnings” from HealthPartners.
10. Heard an update from the CCIIO on its recent activities of interest to the Committee, including its work to support premium rate approval for 2026 and the implementation of the federal 2025 Marketplace Integrity and Affordability Final Rule and The One Big Beautiful Bill Act (OBBBA).
