








Towing Abuse – Legislative Activity

Synthetic Identity Theft

Definition: Combination of PII (legitimate and faked) to fabricate a person or entity for financial gain

• "Traditional" identity theft involves improper usage of an existing person's PII





Synthetic Identity Theft

Where Synthetic IDs are used:



- Vehicle rentals
- Falsification of documents
 - Insurance Policies
 - Counterfeit VINs
 - Cargo Manifests
- Falsification of damages and invoices for repairs

NICB Post Catastrophic Event Response

Hurricanes Helene & Milton

- NICB = Force Multiplier
 - Facilitate timely exchange of critical information
 - Raise public awareness of insurance fraud schemes
 - Aid in life-saving efforts
- Serve First Responders, Law Enforcement, Member Companies, and Communities











Post Catastrophic Event Response

Response to Hurricanes Helene & Milton:

- NICB resources deployed to impacted regions
- NICB direct intel to Helene and Milton emergency operation centers
 - NICB intel used to assist life-saving rescue efforts
- NICB embedded in 11 Insurance Villages
- NICB distributed catastrophe brochures, fraud pamphlets, and fraud prevention signage to the public.
- NICB staff visited shelters, warming centers and basic-needs distribution centers to educate storm victims on how to avoid becoming further victimized by insurance scammers.
