RiverStone Insurance (UK) Limited is in run off and is not considered eligible to sell in any state's surplus lines market.
- (4) This company is limited to write international travel medical insurance for individuals that reside in jurisdictions that allow such medical insurance to be written on a surplus lines basis.
- (5) Effective May 11, 2026, Fidelis Insurance Bermuda Limited changed its name to Pelagos Insurance Capital Bermuda Limited.
- (6) Effective May 11, 2026, Fidelis Underwriting Limited changed its name to Pelagos Insurance Capital Underwriting Limited.
